# CHERRY-TODD ELECTRIC COOPERATIVE, INC MINUTES OF THE BOARD OF DIRECTORS. October 29, 2019

The Regular Meeting of the Board of Directors of Cherry-Todd Electric Cooperative, Incorporated was held October 29, 2019, at 10:25 am CST at the Cooperative office in Mission, South Dakota.

CALL TO ORDER: The meeting was called to order at 10:25 am by Vice President Brickner.

ROLL CALL: Present: Whitney Meek, Dan Valburg, Justin Brickner, Shawn Bordeaux and Wayne Frederick. Absent: Glen Yellow Eagle, Bud Stolzenburg, and Sandy Tucker. Also, in attendance were Manager Timothy Grablander, Administration and Operations Support Manager Steve Tilton, and Attorney David Larson.

AGENDA: Valburg motioned, seconded by Bordeaux, that the agenda be approved as presented. Motion carried.

**MINUTES:** Meek motioned, seconded by Valburg, to accept the minutes of September 24, 2019 as presented. Motion carried.

MANAGER AND STAFF REPORTS: Manager Grablander and Beau Westover discussed service upgrade issues at Saint Francis School. The Board directed them to write a letter explaining the correct procedure to those involved.

Director Yellow Eagle entered the meeting at 10:29 am.

Tilton presented vehicle information for Line Superintendent Mark lyotte as requested by the Board at September Board Meeting. Information was presented on a side by side and a 1-ton pickup to replace the previously sold trucks.

After a lengthy discussion by the Board, Bordeaux motioned, seconded by Yellow Eagle to eliminate the Cooperative's \$20 collection fee. Motion carried unanimously.
